

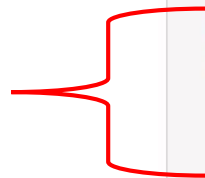

NSU researchers have only two options for groups their research activities fall under.

- Group 1: Biomedical (HPD) Researchers—All researchers in a department within the Health Professions Division (HPD), are required to register for this course.
- Group 2: Social-Behavioral-Educational (non-HPD) Researchers—All researchers that are NOT within the Health Professions Division (HPD), are required to register for this course.

IMPORTANT:

Group 3 and Group 4 are for specific users and the IRB Office will not accept them as proof of the required Human Subjects Training.
