Problems that arise that are unexpected and are NOT Adverse Events that require reporting to IRB are a) unexpected b) related to participation and c) place subject or others at greater risk

Examples:

- Breach of confidentiality
- Loss of data
- Unresolved participant complaints
- Wrongful dose
- Interim findings
